 MCOs have targets for WISe. 				
	 Keep the service intensity and enrollment up and to reduce the interest list.

_	 MCOs have a case load target for each region. Must be met by 85%. 			
_	 Interests list has gone down. The interest list can change month to month. 			
_	 Quality reviews are going to be revised for WISe. 			
_	Is there an expected turnaround on the waitlist for families? It depends on the			
	provider and agency. It can range from days, months to weeks. If a youth is on an			
	interest list for 9 days, 10 being the maximum days, it is considered an Adverse			
	Benefit Determination. It is required to have youth to access WISe services in a			
	timely manner. That is a Medicaid rule. When a youth is on the interest list, they			
	are connected with a Care Coordination staff at the MCO level to ensure they are			
	interim services.			

- CCS currently has a short waitlist. Capacity is slowing growing due to fully staffed in Whatcom County. Skagit County needs a Family Support staff. Position is posted on the CCS website. <u>Job Search / Jobs</u>
- There are five providers for WISe in the North Sound.
- If there is a long interest list the providers can reach out to another county. The 5
 providers are not available every where it depends on each county.
- WISe is referring to Child, Youth, and Family Crisis Team (CYFCT.)
- Are there any trends how long families are connected with WISe? It can be such time of a 9 months to a year families are in services.
- Must have a good transition plan when families graduate from WISe.
- It is a priority to support on going training for staff to support the families being served.
- When a family is put on the waitlist and has started WISe and requests another provider it is the expectation to not have families go back to the bottom of the interest list. CLIP families get moved up on the interest list.
- At CCS is fully staffed in outpatient services.
- WISe can move families within different teams if that is the request from the family.
